The breeder undertakes to pay the full stud fee to EARL DES ECURIES DE CHEVANNES by bank transfer on signing the contract:

The breeder will obtain 12 straws of frozen semen for a single mare for the season, to be used on ovulation.

Additional stud fees: the cost of boarding and insemination for which the breeder is responsible must be paid separately to the stud farmer or inseminator, and will be invoiced separately with no link to the seller.

Unused straws remain the property of the seller, but may be used on another mare with the prior written agreement of EARL DES ECURIES DE CHEVANNES. This additional use will be the subject of a new contract for which the breeder will pay the full amount of the service but without the technical and shipment costs.

In the event of a birth not declared after 12/31/2025, declared illegally, or abroad without the seller's agreement, a flat-rate penalty of €2,500.00 per foal born for the owner(s) of the mare declared at the time of purchase of the covering contract will be applied immediately.

The amounts due under the present contract are payable no later than at the signature of the contract. In the absence of a written declaration, the mare will be considered as pregnant. It is up to the breeder to prove before October 1st, 2024, by means of a veterinary certificate, that the mare has remained empty; if this is not the case, the mare will be considered as pregnant and the balance will not be refund. In the event of an empty mare on October 1, 2024, the contract will be renewed on the same mare for the 2025 season at no extra charge. The breeder will must use the remaining straws. In the event of new straws being sent (in the limit of 8), the breeder will be required to pay the shipping costs (rates available on request).

The breeder may only discharge his payment obligation by producing a veterinary certificate attesting to the mare's vacuity. This certificate must be sent by registered letter before 01/10/2024, otherwise the stud fee cannot be carried over to the 2025 season.

Live foal guarantee: valid only for mares whose vaccinations are up to date (including influenza, tetanus and rhinopneumonitis). If the mare subsequently aborts or if the foal dies within 48 hours of birth: veterinary certificate, copy of vaccinations and declaration of birth must be returned to us, after which the stud fee collected will be deferred in the form of a credit note valid for a CHER EPOUX stud the following year (excluding technical and shipment costs). A live foal is defined here contractually as a newborn foal able to stand and feed without assistance 48 hours after foaling.

Once delivered to the insemination center, the straws are at the breeder's risk.

In the event of sale of his mare, the breeder remains solely responsible for the above clauses vis-à-vis the seller. In the event of fraudulent breach of these conditions, the breeder will be liable to a fixed fine of €2,500.00 as a penalty clause.

PRACTICAL INFORMATION:

Shipment is not automatic, but is carried out at the breeder's request.

Shipment is made on request by calling +33 662.632.580 before 9:30 a.m. (GMT+1) for next-day delivery, Monday to Friday. All requests must be confirmed by email or SMS.

One original of the contract will be kept by the breeder and the other original will be sent to the seller with proof of payment. All contracts returned without full payment will be considered null and void.

Contracts must be sent, completed, signed and accompanied by the proof of payment before any straws order is placed, to the following address:
